UMMELI WAKHO – UMELULEKI ONGAMETHEMBA

Kuyokwenzekani ngefa lami nempahla yami lapho sengishonile?

Indlela engcono kakhulu yokuqinisekisa ukuthi lapho usushonile impahla yakho ipathwa ngokuvumelana nezifiso zakho neziqondiso iwukuba ubhale incwadi yefo. Lokhu kukunika ithuba lokukhetha uMabi Wefa ozonakelela impahla yakho. Uma ushona ungenayo incwadi yefo, umndeni wakho ungase ubhekane nezingqinamba kanye nezinkinga ezinkulu.

Uma umuntu eshona engenayo incwadi yefo efanele, impahla yakhe izodlulisewa kwabanye ngokuvumelana noMthetho Wokudluliswa Kwefa. Ezimweri ezinjalo, ifa izodlulisewa koshade naye osaphila nomu kuyenena nezingane zomufi nabazukulu (uma ingane ishone ngaphambi komufi kodwa yashiya izingane). Uma zingekho izingane, ifa izodlulisewa kubazali, futhi uma nabo bengasekho, kubafowenu nodadewenu.

Ukusingathwa kwezindaba zefa lomufi kuqala kanjani?

Uma umuntu eshona eshiya ifa nomu incwadi yefo, umuntu ashade naye osaphila — nomu uma engekho, isihlobo esiseduze esihlala esifundeni ashonele kuso — kumelwe sibike ifa ngokwendlela echaziwe eNkosini YeNkantolo

Le ncwajana izokwazisa ngamaphuzu asemqoka okuphathwa kwefa lomufi, kanye nezindaba zomthetho ezhilelekile.

Kutuswa ukuba uthintane nommeli wakho ukuze ubhale incwadi yefo futhi kutuswa ukuba ummeli wakho akhethwe njengoMabi Wefa encwadini yakho yefo.

Ummeli wakho

- uzokucebisa nganoma iziphi izinkinga ezingase zivele;
- uzosingatha zonke izinkinga zeomthetho ezingase ziphakame;
- unolwazi nobuchule obudingekayo ukuze aqinisekise ukuthi incwadi yakho yefo ibhalwa ngokuvumelana neziyalezo zakho, futhi
- uyoginisekisa ukuthi incwadi yakho yefo ibhalwe kahle, ilondolozwa kahle futhi iyasebenza ngokuvumelana noMthetho Wezincwadi Zamafa.

Ephakeme (Master of the High Court), zingakapheli izinsuku ezingu-14.

Lapho impahla/ifa selibikiwe, iNkosi YeNkantolo ikhetha uMabi Wefa ngokukhipha iNcwadi Yokwabiwa Kwefa (uma impahla yomufi iyingani elingapezu kuka-R125 000) noma iNcwadi Yokugunyaza (uma impahla yomufi ingaphansi kwenani elingu-R125 000).

Ummeli wakho unolwazi nobuchule bokokusiza ngokulungiselela izincwadi ezidingekayo zokubika nokunakelela ukusingathwa kwempahla ngendlela efanele.

Ubani ongase akhethwe njengoMabi Wefa ukuze asin-gathe ukwabiwa kwempahla?

Kutuswa ukuba ummeli wakho akhethwe njengoMabi Wefa ngoba

- ujwayelene neziqondiso ezsencwadini yakho yefo,
- uyazi ukuthi impahla yakho ikuphi,
- unolwazi oluningiliziye ngezindaba zomndeni wakho,
- uzoba sesimweni esingcono sokuhlanganisa impahla yakho futhi anakekele ukubhaliswa kwefa elidluliswayo futhi lokhu akwenze ngobunono, futhi
- unolwazi olukhethekile Iwenqubo yokusingathwa kwezindaba zefa.

Kodwa-ke, ilungu lomndeni nalo lingakhethwa njengoMabi Wefa lisizane nommeli wakho.

Iyini indima efezwa uMabi Wefa?

UMabi Wefa kulindeleke ukuba

- ahlanganise impahla yomufi,
- akhokhe izikweletu zakhe,
- akhokhe yonke impahla eyabiwe ngefa, futhi
- abele izindlalifa ifa elisele ngokuvumelana nencwadi yefo yomufi, nomu ngokuvumelana noMthetho Wokudluliswa Kwefa uma umufi eshone engayibhalanga incwadi yefo.

Ngaphansi kwezimo ezithile ezingavamile, uMthetho Wokuphathwa Kwamafa uyavumela owakwakho osaphila ukuba athathe ifa lomufi nomu ingxene yalo, uma kunesiqinisekiso esifanele sowakwakho osaphila sokuthi

uyonakekela ifa lanoma iziphi izingane ezsencane. Izindlalifa nazo zinelungelo lokungena eSivumelwaneni Sokwabiwa Kwefo okuyodingeka sibuye sinikwe iNkosi YeNkantolo ukuze isigunyaaze. Ngokuvamile ngaphansi kwalezi zimo ummeli unekeza iseluleko njengochwepeshe.

Yini enye okufanele umuntu ayazi ukuze azizwe ekhululekile ngenqubo yokunakekelwa kwezindaba zefa?

Ngaphambi kokuba imidanti itholakale ukuze ihlolwe, uMabi Wefa, egunyazwe iNkosi YeNkantolo, angakhiphia inani elithile lemalu nanoma iyiphi impahla efeni uma uMabi Wefa ekubona kufaneleka lokho ukuze kunakekelwe izidingo zomndeni womufi.

Ngaphezu kwalokho, uma impahla ikwazi ukukhokhela izikweletu futhi kunemali eyanele, uMabi Wefa angakhiphia imali ayinike izindlalifa nabantu ababelwe ifa ngokuvumelana nokwabiwa kwalo. Lokhu kunjalo ikakhlulukazi uma indlalifa iwumkamufi/umyeni wakhe noma lapho kungase kubambezeleke ukusingathwa kwendaba.

Yini eyenzekayo nge-akhawunti yefa?

Ngemva nje kokubikwa kwempahla, uMabi Wefa uthola inani lempahlha kanye nezikweletu ezihilelekile ngesikhathi sokushona komufi.

Ngemva kokuhishwa kweziNcwadi Zokwabiwa Kwefo, uMabi Wefa kumelwe akhiphe isaziso kuyi-Government Gazette nasephehandabeni elilodwa noma ngaphezelu esifundeni umufi abehlala kuso, acele bonke abantu abakweletwayo kuleli fa ukuba bafake izikhalo kuMabi Wefa phakathi nesikhathi esinqunyiwe, ngokuvamile esiyizinsku ezingu-30 kusukela ngosuku lwasaziso sokugcina.

Ngemva kwalokho, kodwa kungakedluli izinyanga ezingu-6 kukhishwe iziNcwadi Zokwabiwa Kwefo noma sekndlule isikhathi iNkosi YeNkantolo engase isivumele, uMabi Wefa unesibopho sokuthumela eNkosini YeNkantolo irekhodi lokudayiswa kwempahla nokwabiwa kwefo.

iNkosi YeNkantolo izohlola imidanti, futhi uma konke kusesimweni esifanele, igunyaaze uMabi Wefa ukuba akhiphe isaziso ngale midanti ukuze ihlolwe. Imidanti

yoMabi Wefa kufanele igcinwe obala eHhovisi LeNkosi YeNkantolo – futhi uma umufi ebehla kwsinye isifunda, ikhophi yale midanti kufanele igcinwe emafayelin omphakathi ehhovisi leMantshi – izinsuku ezingengaphansi kwezingu-21, ukuze ihlolwe inoma imuphi umuntu ofuna ukwazi ngefa. UMabi Wefa kumelwe akhiphe isaziso kuyi-Government Gazette nasephehandabeni elilodwa noma ngaphezelu asakazwa esifundeni umufi abehlala kuso esisho isikhathi le midanti ezogcinwa ngaso nendawo ezogcinwa kuyo ukuze ihlolwe.

Uma isikhathi sokuhola sesidlulile, iNkosi YeNkantolo izokwazisa uMabi Wefa ukuthi imidanti ebicinewe ukuhlolwa ayiphikiswanga muntu. UMabi Wefa angabe esekhokhela abakweletwayo futhi abele izindlalifa ifa ngokuvumelana nemidanti. UMabi Wefa uzothumela eNkosini YeNkantolo wonke amarisidi namarekhodi abantu abakweletwayo nalokho okwabelwe izindlalifa.

Uma uMabi Wefa ephethi imali engu-R1 000 noma ngaphezelu, kufanele avule i-akhawunti yefa. Kodwa-ke, lokhu akusebenzi uma ummeli ophethe indaba esebezisa i-akhawunti yakhe ukuze abe izimali zomufi.

Intel i-Value Added Tax, i-Capital Gains Tax ne-Income Tax

UMabi Wefa kufanele athole ukuthi impahla kufanele yini ikhokhe i-value added tax (VAT) kanye/noma i-income tax.

Uma umufi ebebaliswe njengomdayisi uMabi Wefa kungase kudingke abhalise ifa ukuze ngenjongo ye-VAT. Lokhu kuyokwenza ukuba kudonswe i-VAT. Kungase kudingke ukuba uMabi Wefa akhokhe intela kwabakwa South African Revenue Service ngayo yonke impahla yebhizinisi lomufi. UMabi Wefa angase akwazi ukudayisa ibhizinisi komunye usomabhizinisi okhokha i-VAT futhi lelo bhizinisi lifakwe ngaphansi kwasigaba i-'zero rated'.

UMthetho We-Income Tax unenkambiso yokuthi uma umuntu eshana, kuthathwa ngokuthi ufake yonke impahla yakhe ngaphansi kwefo lomufi ngemali ayitholile noma egginiwe elingana nenani lokuthenga leyo mpahla, futhi impahla yomufi ibhekwa njengeuze lelo nani ngokwesilinganiso sezimakethe. Lesi isimiso esivame ukusetshenziswa, kodwa ngezinye izikhathi kungase kwensiwe okuhlukile. Ngokwesibonelo, impahla yomyeni/inkosikazi esaphila ngemva kokushona kowakwakhe

ayibhekwa njengempahla ebisidayisiwe ngesikhathi sokushona komufi.

Empahleni eningi kuye kudonswe i-income tax. Lokhu kungase kube nomthelela enanini lemalu ezokwabelwa izindlalifa.

Idonswa nini intela yefa?

Okwamanje intela yefa idonswa emalini yefa eyisilinganiso esingu-20%. Imali edonswayo ibalwa ngokudonsa inani eligodlwayo elingu-R3.5 million 'enanini lalo lonke ifa'. Inani layo yonke impahla ehlanganiswe efeni lomufi elingelowakwakhe osaphila, ngokusho kwencwadi yomufi yefa noma ngokuvumelana nomthetho wokudluliswa kwefo, lingase lidonswe uma lihlanganisiwe empahleni yefa.

Ingabe kukhona indlalifa engakhetha kukho?

Noma iyiphi indlalifa inelungelo lokwenqaba noma lokulahla isipho noma ifa elinikwayo.

Kuye kukhethwe uma abashadile behlanganise impahla yabo futhi osaphila kumelwe akhethe ukuthi uthatha isabelo sakhe futhi alahlekelwe izinzuzo zefo elihlanganyelwe, noma uyavuma ukuba ifa lakhe lidayiswe futhi athole izinzuzo zalokho. Lokhu kukhetha komuntu osaphila ngokuvamile kubizwa ngokuthi i-'adiation'.

Uma indlalifa ingalamukeli ifa, lelo fa lizodluliswa ngokuvumelana nencwadi yomufi yefa noma ngokuvumelana nemithetho yokudluliswa kwefo.
